## WORD 2007—COMING TO A COMPUTER NEAR YOU!

Some agencies have been upgraded from Word 2003 to Word 2007. RIS should work just fine. Here are a couple of pointers:

Look under the Add-Ins tab on the new "ribbon" to find your RIS toolbar. If it's not there, try reloading the macro from the Tools link in the RIS toolbar.

If your Word documents in RIS do not seem to close properly after clicking RIS Update, check that the Control Panel setting is still set so the three boxes are unchecked. Click [here](#) for more detailed user instructions

## VIRGINIA REGISTER FILING DEADLINE

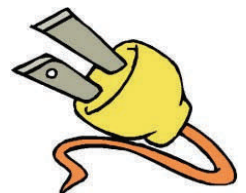
In order to accommodate the May 28 furlough day and the May 31 Memorial Day holiday, the Virginia Register filing deadline for the June 7, 2010, Virginia Register (26:20), is changed to **Tuesday, May 18,**

## FILING PETITIONS FOR RULEMAKING

Effective immediately, a petition for rulemaking is considered filed when the Registrar's office receives the automatically generated email notification from the Virginia Regulatory Town Hall. You no longer need to fill out and email a separate petition for rulemaking transmittal form. **However, PLEASE check the Register to be sure all agency filings are published as expected.**

## RIS "UNPLUGGED" MAY 8 AND 15

RIS will not be available on May 8 and May 15 due to electrical outages in the General Assembly Building for general maintenance.
