

CUMULATIVE TABLE OF AMENDED, ADDED, AND REPEALED SECTIONS**What is the Cumulative Table of Amended, Added, and Repealed Sections?**

The [cumulative table](#) lists regulation sections that have been amended, added, or repealed in the *Virginia Register* since the regulations were originally published or last supplemented in the print version of the Virginia Administrative Code (the Fall 2009 VAC Supplement includes final, fast-track, and emergency regulations published through *Virginia Register* Volume 25, Issue 26, dated August 31, 2009, and fast-track regulations published through *Virginia Register* Volume 25, Issue 24, dated August 3, 2009). The cumulative table lists the sections in numerical order and shows the action taken, the volume, issue, and page number where the section appeared, and the effective date of the section. Also, corrections published in the "Errata" section of the Register that affect final, fast-track, and emergency regulations are listed in the cumulative table.

Why is it important?

- **Future amendments:** The online VAC database is updated daily and reflects all currently effective regulations. The cumulative table shows you those sections that have completed the regulatory process, but may have not yet become effective.
- **Print or CD versions of VAC:** If you are using the semiannual print or quarterly CD version of VAC, the table identifies any sections that have been amended since the last print or CD update.

How often is it updated?

The cumulative table is updated about the same time as the most current edition of the *Virginia Register* is available online.

How do I find and use it?

- Go to <http://register.dls.virginia.gov/CUMULTAB.HTM>.
- Scroll down until you find the section number you are interested in.
- If the section number is not listed, the section has not been amended or repealed since the last print supplement or quarterly CD update was issued, and no amendments are pending.
- If the section number is listed, look at the CITE column to find the volume, issue, and page number of the *Virginia Register* where it was published. Go to the [Virginia Register Online](#) and select the applicable issue of the *Virginia Register* to look at the text.

Example:

To see if any amendments are pending for the **Board of Agriculture and Consumer Services' Food Regulations (2VAC5-585)**:

- Open the [cumulative table](#).
- Look for "2 VAC 5-585." You will see a long list of sections under this chapter that are noted as "amended" and "repealed" in Volume 26, Issue 7 beginning on page 773 to become effective January 1, 2010. To see the sections as they will become effective on January 1, 2010, open [Volume 26, Issue 7](#), find "2VAC5-585" on the table of contents page, and click on the page number to go directly to the regulation.


