## TITLE 20. PUBLIC UTILITIES AND TELECOMMUNICATIONS

### STATE CORPORATION COMMISSION

Title of Regulation: **20 VAC 5-312. Rules Governing Retail Access to Competitive Energy Services (amending 20 VAC 5-312-100; adding 20 VAC 5-312-120).**

Statutory Authority: §§ 12.1-13, 56-235.8, and 56-581.1 of the Code of Virginia.

#### Summary:

*The proposed amendment deletes subsection H of 20 VAC 5-312-100, an existing provision addressing interval metering, from the load profiling provisions. Similar but revised language from deleted subsection H of 20 VAC 5-312-100 is included in the proposed section for electricity metering, 20 VAC 5-312-120. The purpose of the newly proposed electricity metering section is to ensure the availability of metering services that will enhance the development of a competitive electricity market in Virginia. The proposed rules require the local distribution company to provide interval metering services, including access to interval data, to customers or the customer's authorized competitive service provider. The rules address interval metering for customers that already receive interval metering as the basic metering service; how the local distribution company shall respond to requests for interval metering; the options the local distribution company must provide to retail customers and their authorized competitive service providers to access unedited interval data; reading and storage of interval data, as well as provision of historical data relative to interval meters; and requests for special metering functionality.*

## **20 VAC 5-312-100. Load profiling.**

A. The local distribution company shall conduct its load profiling activities in a nondiscriminatory and reasonably transparent manner.

B. The local distribution company shall ensure that profile classes are easily identifiable, that load profiles used are representative of the customer class being profiled, and that

customer loads are represented in a nondiscriminatory manner. Load profiles and load profiling methodologies shall be reviewable and verifiable by the State Corporation Commission.

C. The local distribution company shall provide a competitive service provider, through the appropriate regulatory process, access to sample data, excluding any customer-specific identifier, that is necessary to verify the validity and reliability of load profiles and methodologies.

D. The local distribution company shall use a load profiling method that balances ease of implementation with the need for the load profile to reasonably represent and predict the customer's actual use. The method used shall balance the need for accuracy, cost-effectiveness for the market, predictability, technical innovation, lead time to implement, demonstrated need for market data, and sample bias. The validity of the approach needs to be reconfirmed periodically or as markets evolve, and corresponding load profiles shall be updated accordingly and made available to competitive service providers.

E. The local distribution company shall make available to a competitive service provider the validated and edited customer class or segment load profile via a website in a read-only, downloadable format or by other appropriate cost-effective electronic media. The information shall be date stamped with the date posted and the date created, and the website or other electronic media shall clearly indicate when updated information has become available.

F. A customer's assigned load profile shall remain the same regardless of the provider of electricity supply service. Customer loads that are not metered, such as streetlights, may be represented by load profiles deemed to closely reflect their known patterns of usage.

G. The load sample may include both customers served by the local distribution company, or the default service provider as determined by the State Corporation Commission pursuant to § 56-585 of the Code of Virginia, and customers served by a competitive service provider, such that a customer is not automatically removed from the load sample when the customer begins to receive service from a competitive service provider.

~~H. Upon a customer's request, the local distribution company shall provide interval metering service to the customer at the net incremental cost above the basic metering service provided by the local distribution company. If the local distribution company provides interval metering as the basic metering service in accordance with its applicable tariff, interval metering of a customer's load shall continue to be required if such customer purchases electricity supply service from a competitive service provider.~~

~~H.~~ H. The local distribution company shall post its distribution and transmission loss factors via the appropriate electronic methodology.

## **20 VAC 5-312-120. Electricity metering.**

*A. If the local distribution company provides interval metering as the basic metering service in accordance with its applicable tariff, interval metering of a customer's load shall continue to*

be required if the customer purchases electricity supply service from a competitive service provider. Unless other arrangements are agreed upon between the local distribution company and the customer, the local distribution company may remove the interval meter if the customer's load deteriorates below previously established interval metering thresholds.

B. Upon a customer's request, the local distribution company shall provide interval metering service to the customer at the net incremental cost above the basic metering service provided by the local distribution company. The local distribution company shall reply to the customer in writing within five business days of the request for interval metering service, acknowledging the request and identifying the prerequisites and proposed process for completing the work. The local distribution company shall complete the work within 45 calendar days, or as promptly as working conditions permit.

C. The local distribution company shall offer each of the following options to customers or their authorized competitive service provider to access unedited interval data consistent with the local distribution company's communication protocol: (i) read-only electronic access to the interval billing meter, (ii) receipt of a stream of data pulses proportional to energy usage, and (iii) both of the foregoing.

D. The local distribution company shall read interval meters at a frequency in accordance with its applicable terms and conditions and shall store interval meter data at intervals compatible with wholesale load settlement requirements. Interval meter data may be estimated on occasion as necessary. The local distribution company shall make available to customers or their authorized competitive service provider 12 months of historical edited interval data through electronic communication medium or mail, as mutually agreed.

E. The local distribution company shall consider reasonable requests from customers or their authorized competitive service provider to evaluate special metering functionality and shall reply to the requests in writing within five business days, acknowledging the request and identifying the cost and process for completing the work. The local distribution company shall complete the work within 45 calendar days, or as promptly as working conditions permit.

## TITLE 18. PROFESSIONAL AND OCCUPATIONAL LICENSING

### BOARD OF PSYCHOLOGY

Title of Regulation: **18 VAC 125-30. Regulations Governing the Certification of Sex Offender Treatment Providers (amending 18 VAC 125-30-10 through 18 VAC 125-30-50, 18 VAC 125-30-80, and 18 VAC 125-30-90; repealing 18 VAC 125-30-60).**

Statutory Authority: §§ 54.1-2400 and 54.1-3605 of the Code of Virginia.

Effective Date: April 10, 2002.

#### Summary:

*The amendments make the miscellaneous fees consistent with other professions regulated by the board, provide clarification about supervised experience required prior to certification, and revise reinstatement requirements. The number of clock hours of required training remains at 50, but more of those hours must be in subjects specific to sex offender assessment and treatment interventions.*

#### 18 VAC 125-30-10. Definitions.

The following words and terms when used in this chapter shall have the following meanings, unless the context clearly indicates otherwise:

*"Ancillary services"* means training in anger management, stress management, assertiveness, social skills, substance abuse avoidance and sex education as part of an identified sex offender treatment provider program.

*"Applicant"* means an individual who has submitted a completed application with documentation and the appropriate fees to be examined for certification as a sex offender treatment provider.

*"Assessment"* means using specific techniques of evaluation and measurement to collect facts related to sexually abusive thoughts and behaviors contributing to sexual offense.

*"Board"* means the Virginia Board of Psychology.

*"Certified sex offender treatment provider"* means a person who is certified to provide treatment to sex offenders and who provides such services in accordance with the provisions of §§ 54.1-2924.1, 54.1-3005, 54.1-3505, 54.1-3609, 54.1-3610,

54.1-3611, and 54.1-3705 of the Code of Virginia and the regulations promulgated pursuant to these provisions.

*"Competency area"* means an area in which a person possesses knowledge and skills and the ability to apply them in the clinical setting.

*"Sex offender"* means (i) any person who has been adjudicated or convicted of a sex offense or has a founded child sexual abuse status by the Department of Social Services; (ii) any person for whom any court has found sufficient evidence without specific finding of guilt of committing a felony or misdemeanor which may be reasonably inferred to be sexually motivated; or (iii) any person who admits to or acknowledges behavior which would result in adjudication, conviction, or a founded child sexual abuse status.

*"Sex offense"* means behavior in violation of any of the following statutes in the Code of Virginia: § 18.2-48 in part (abduction of any person with intent to defile such person), § 18.2-60.3 in part (includes only those instances in which sexual motivation can be reasonably inferred), § 18.2-61, § 18.2-63, § 18.2-64.1, § 18.2-67.1, § 18.2-67.2, § 18.2-67.2:1, § 18.2-67.3, § 18.2-67.4, § 18.2-67.5, § 18.2-130 in part (includes only those instances in which sexual motivation can be reasonable inferred), subsection A of § 18.2-361 in part "If any person carnally knows in any manner any brute animal" and subsection B § 18.2-361 in its entirety, § 18.2-366, § 18.2-370, § 18.2-370.1, § 18.2-374.1 (not to include plethysmographic testing materials in the possession of qualified mental health professionals or technicians), § 18.2-387.

*"Supervision"* means the ongoing process performed by a supervisor who monitors the performance of the person supervised and provides regular documented individual consultation, guidance and instruction with respect to the skills and competencies of the person providing sex offender treatment services.

*"Supervisor"* means an individual who assumes full responsibility for the education and training activities of a person as it relates to sex offender treatment and provides the supervision required by such a person. The supervisor ~~must~~ *shall* be a certified sex offender treatment provider and licensed by the Board of Medicine, Nursing, ~~Licensed Professional Counselors, Marriage and Family Therapists, and Substance Abuse Professionals;~~ *Counseling, Psychology or Social Work.*

*"Treatment"* means therapeutic intervention to change sexually abusive thoughts and behaviors which specifically addresses the occurrence and dynamics of sexual behavior and utilizes specific strategies to promote change.

A. The board has established the following fees applicable to the certification of sex offender treatment providers:

~~A. A candidate for certification as a sex offender treatment provider shall meet all the requirements of this chapter.~~

~~B.~~ A. Every applicant for certification by the board shall:

1. Meet the educational requirements prescribed in 18 VAC 125-30-40;
2. Meet the experience requirements prescribed in 18 VAC 125-30-50 and ~~18 VAC 125-30-60~~;
3. Submit to the executive director of the board:
  - a. A completed application form;
  - b. Documented evidence of having fulfilled the education, experience and supervision set forth in 18 VAC 125-30-40, and 18 VAC 125-30-50, ~~and 18 VAC 125-30-60~~; and
  - c. Reference letters from three [*licensed*] health care professionals familiar with and attesting to the applicant's skills and experience.

~~C.~~ B. The board may certify by endorsement an individual who can document current certification as a sex offender treatment provider in good standing obtained by standards substantially equivalent to those outlined in this chapter as verified by an out-of-state certifying agency on a board-approved form.

## 18 VAC 125-30-40. Educational requirements.

An applicant for certification as a sex offender treatment provider shall:

1. Document completion of one of the following degrees:
  - a. A master's or doctoral degree in social work, psychology, counseling, or nursing from a regionally accredited university;

b. The degree of Doctor of Medicine or Doctor of Osteopathic Medicine from an institution that is approved by an accrediting agency recognized by the Virginia Board of Medicine; or

c. A comparable degree acceptable to the board.

Graduates of institutions ~~which that~~ are not accredited by an acceptable accrediting agency shall establish the equivalency of their education to the educational requirements of the Virginia Board of Social Work, Psychology, ~~Licensed Professional Counselors, Marriage and Family Therapists, and Substance Abuse Professionals~~, Counseling, Nursing or Medicine.

2. Provide documentation of 50 clock hours of training acceptable to the board in the following areas, with ~~at least 40~~ 15 clock hours in each area identified in subdivisions 2 a and b of this section, 10 clock hours in each area identified in subdivision 2 c of this section, and five clock hours in each area identified in subdivisions 2 d and e of this section:

- ~~a. Etiology/developmental issues of sex offense behavior;~~
- ~~b. a. Sex offender assessment;~~
- ~~c. b. Sex offender treatment interventions;~~
- c. Etiology/developmental issues of sex offense behavior;
- d. Criminal justice and legal issues related to sexual offending; and
- e. Program evaluation, treatment efficacy and issues related to recidivism of sex offenders.

## 18 VAC 125-30-50. Experience requirements; supervision.

A. An applicant for certification as a sex offender treatment provider shall provide documentation of having 2,000 hours of post-degree clinical experience in the delivery of clinical assessment/treatment services. At least 200 hours of this experience must be face-to-face treatment and assessment with sex offender clients.

## ~~18 VAC 125-30-60. Supervision requirement.~~

~~A. Hours. After August 6, 1998, The experience set forth in 18 VAC 125-30-50 shall also include a minimum of 100 hours of face-to-face supervision within the 2,000 hours experience with a minimum of six hours per month. A ~~maximum~~ minimum of 50 hours of this shall be in individual face-to-face supervision. Face-to-face supervision may be obtained in a group setting including up to shall include no more than six trainees in a group.~~

B. Supervised experience obtained in Virginia without prior written board approval shall not be accepted toward certification. Candidates shall not begin the experience until after completion of the required degree as set forth in 18 VAC 125-30-40. An individual who proposes to obtain supervised post-degree experience in Virginia shall, prior to the onset of such supervision, submit a supervisory contract along with the application package and pay the registration of supervision fee set forth in 18 VAC 125-30-20.

~~B.~~ C. The supervisor.

1. The supervisor shall assume responsibility for the professional activities of the applicant.
2. The supervisor shall not provide supervision for activities for which the prospective applicant has not had appropriate education.
3. The supervisor shall provide supervision only for those sex offender treatment services which he is qualified to render.
4. At the time of formal application for certification, the board approved supervisor shall document for the board the applicant's total hours of supervision, length of work experience, competence in sex offender treatment and any needs for additional supervision or training.

~~G.~~ **D. Registration of supervision.**

1. ~~Individuals who wish~~ *In order to register supervision with the board, individuals shall submit in one package:*
  - a. A completed supervisory contract;
  - b. The registration fee prescribed in 18 VAC 125-30-20; and
  - c. Official graduate transcript.
2. The board may waive the registration requirement for individuals who have obtained at least five years documented work experience in sex offender treatment in another jurisdiction.

*E. Supervised experience obtained prior to [ ~~effective date of these regulations~~ April 10, 2002, ] may be acceptable if they met the board's requirements that were in effect at the time the supervision was rendered.*

**18 VAC 125-30-80. Annual renewal of certificate.**

- A. Every certificate issued by the board shall expire on June 30 of each year.
- B. Along with the renewal application, the certified sex offender treatment provider shall submit the renewal fee prescribed in 18 VAC 125-30-20.
- C. *Certificate holders shall notify the board in writing of a change of address within 60 days.* Failure to receive a renewal notice and application form(s) shall not excuse the certified sex offender treatment provider from the renewal requirement.

**18 VAC 125-30-90. Reinstatement.**

- A. A person whose certificate has expired may renew it within ~~two years~~ *one year* after its expiration date by paying the renewal fee and the ~~reinstatement~~ *late renewal* fee prescribed in 18 VAC 125-30-20.
- B. A person whose certificate has expired beyond ~~two years~~ *one year and who wishes to resume practice* shall:
  1. Submit a reinstatement application along with the ~~renewal and reinstatement fees and fee.~~
  2. Provide evidence satisfactory to the board of current ability to practice.

3. *Submit verification of any professional certification or licensure obtained in any other jurisdiction subsequent to the initial application for certification.*

## EXECUTIVE ORDER NUMBER EIGHT (2002)

### **ESTABLISHING THE GOVERNOR'S ADVISORY COMMISSION ON HIGHER EDUCATION BOARD APPOINTMENTS**

The Commonwealth of Virginia is justifiably proud of its outstanding system of higher education. The hard work and dedication of the citizen boards that govern our higher education institutions have been an important part of their success. It is critical to the future success of higher education that we have governing bodies that are inclusive and reflect the diversity of our students, our professors, and our Commonwealth. To achieve our goal of having one of the best systems of higher education in the world, it is vitally important that members of higher education governing boards are selected based on merit, experience, sound judgment, and proven leadership.

By virtue of the authority vested in me under Article V of the Constitution of Virginia, and by Section 2.2-134 of the Code of Virginia, I hereby establish the Governor's Advisory Commission on Higher Education Board Appointments (the "Commission").

The Commission is classified as a gubernatorial advisory commission in accordance with Sections 2.2-134, 2.2-135, and 2.2-2100 of the Code of Virginia. The purpose of this Commission shall be to review and evaluate potential appointees to the governing bodies of Virginia's institutions of higher education, the Virginia Community College Board, and the State Council of Higher Education for Virginia.

The Commission shall have seven members appointed by the Governor and serving at his pleasure. In addition, the Secretary of Education and the Secretary of the Commonwealth shall serve as non-voting ex-officio members of the Commission. Members of the Commission shall serve without compensation.

The Commission shall develop and implement a process for evaluating potential appointees to higher education governing boards based on substantive qualifications such as merit and experience. The Commission also shall make other recommendations to the Governor as may be appropriate.

The Commission shall make its recommendations to the Governor at least 30 days prior to the expiration of the term for which the Commission is making the recommendations. The Office of the Secretary of the Commonwealth shall provide to the members of the Commission copies of resumes and correspondence it receives related to the relevant board appointments.

Such staff support as is necessary for the conduct of the Commission's work during the term of its existence shall be furnished by the Office of the Secretary of the Commonwealth, with support from the Office of the Secretary of Education, the State Council of Higher Education for Virginia, and such other executive agencies as the Governor may designate. An estimated 1,200 hours of staff time will be required to support the commission.

Such funding as is necessary for the term of the Commission's existence shall be provided from sources, including both

private and appropriated funds, contributed or appropriated for purposes related to the work of the Commission, as authorized by Section 2.2-135(B) of the Code of Virginia. Direct expenditures for the Commission's work are estimated to be \$8,000.

This Executive Order shall be effective upon its signing, and shall remain in full force and effect until February 6, 2003, unless amended or rescinded by further executive order. Given under my hand and under the Seal of the Commonwealth of Virginia, this 7th day of February, 2002.

### ORDER FOR NOTICE AND COMMENT

On December 20, 2001, Birchwood Power Partners, L.P. ("Birchwood" or "Company"), filed with the State Corporation Commission ("Commission") a petition seeking the Commission to declare that its generating facility ("Facility") located in King George County may cease operation as a qualifying cogeneration facility ("QF") under the Public Utilities Regulatory Policies Act ("PURPA") and commence operation as a non-qualifying electric generating facility without obtaining a certificate of public convenience and necessity ("CPCN") from the Commission. In the alternative, Birchwood proposed that if the Commission finds that a certificate is required, the Company's Petition be treated as an application for a CPCN.

By way of background, and as set forth more fully in the Company's Petition, Birchwood is a limited partnership owned by Mirant Birchwood, Inc. ("Mirant Birchwood"), and Cogentrix/Birchwood Two, L.P. ("CB-Two"). Mirant Birchwood is ultimately owned by Mirant Corporation and CB-Two is ultimately owned by Cogentrix Energy, Inc. Birchwood's Facility (the subject of this Petition) has been operated as a QF pursuant to PURPA since 1996. Thermal output from the Facility is sold to Greenhost, Inc., which uses such output to operate a greenhouse complex. The steam-turbine generator has a net electric power production capacity of approximately 242.2 MW. All of the electric capacity and energy from the Facility is sold to Virginia Electric and Power Company d/b/a Dominion Virginia Power ("Virginia Power") under a Power Purchase and Operating Agreement ("PPOA") and a Supplemental Capacity Power Purchase and Operating Agreement ("Supplemental PPOA") between Birchwood and Virginia Power.

According to the Petition, the Facility is fully dispatchable, based upon Virginia Power's demand requirements. The Company states that both the PPOA and the Supplemental PPOA explicitly recognize that Birchwood may operate the Facility as a QF or a non-QF electric generating facility. Furthermore, Birchwood states that the PPOA will expire in 2021, unless extended, and that the Supplemental PPOA expires in 2003, unless extended. The Company indicates that both the PPOA and the Supplemental PPOA resulted from bidding procedures implemented by Virginia Power and approved by the Commission. Thus, according to the Company, none of the foregoing is predicated on the Facility maintaining its status as a QF.

The Company also indicates in its Petition that Birchwood has obtained authorization from the FERC to own and operate the Facility as an exempt wholesale generator ("EWG"). Further, the Company states that to operate as a non-QF electric generating facility, Birchwood will also seek FERC approval of its wholesale sales rates.

At the heart of this application is Birchwood's plan to cease operating the Facility as a QF and to operate it instead as a non-QF electric generating facility. Thus, according to the Company, the Facility no longer will be required to meet the technical requirements of a cogeneration QF, producing both steam and electricity for sale, but instead may operate solely as an electric generating facility. Birchwood believes that, as a matter of law, it is not required to obtain a CPCN from the Commission in order to operate the Facility as a non-QF electric generating facility. Therefore, the Company seeks a declaratory ruling from the Commission that no certificate is required for that purpose. In the alternative, Birchwood states that if the Commission determines that a certificate is required, then the Company requests the Petition be treated as an application to the Commission for a CPCN.

Birchwood argues in its Petition that the Virginia Utility Facilities Act ("Facilities Act"), Va. Code § 56-265.1 et seq., requires a public utility to obtain a certificate in two sets of circumstances, neither of which—in the Company's view—are pertinent to the Company's plans to operate as a non-QF. Birchwood first asserts that Va. Code § 56-265.2 does not apply to it because the Company does not seek to "construct, enlarge, or acquire" any facility. Secondly, the Company contends Birchwood does not have to obtain a certificate under Va. Code § 56-265.3 A, which makes it unlawful for a public utility to furnish public utility service in an exclusive service territory without having first obtained a certificate, because Birchwood is not furnishing traditional "public utility service." Inasmuch as Birchwood (as a non-QF) does not seek to furnish public utility service within an exclusive territory but only intends to operate its electric generating facility to sell to power to Virginia Power for resale under negotiated agreements, the Company argues that this fact lends further weight to its view that the Facilities Act's requirements for certification are inapplicable in these circumstances.

The Company notes in its Petition that the Commission has required certain independent power producers to obtain certificates pursuant to Va. Code § 56-265.2, but not pursuant to Va. Code § 56-265.3, and that the Commission has not issued rules to guide applications to "operate" generation

facilities similar to the circumstances presented here. In addition, Birchwood explains that § 56-577 A 3 of the Virginia Electric Utility Restructuring Act, Va. Code § 56-576 et seq. ("Act"), provides that the generation of electricity shall no longer be subject to regulation under Title 56 other than as specified in the Act. Birchwood points out that the Commission, in the recent case establishing new rules for "merchant plant" electric generation facilities, relied on that provision of the Act in holding that § 56-265.2 will no longer apply to applications to construct new generation in the Commonwealth on and after January 1, 2002.<sup>1</sup> The Company argues that although the Commission limited its ruling in PUE010313 to the impact of the Act on Va. Code § 56-265.2 (and § 56-234.3), the rationale supporting that ruling applies to § 56-265.3 and, thus, Birchwood should not be required to obtain a CPCN in this case. Finally, the Company argues that if the Commission determines a CPCN is required, the operation of the facility as a non-QF would satisfy the "public convenience and necessity" as the Commission has applied that phrase in granting CPCNs to electric generation facilities.

Birchwood's petition raises a number of issues not previously addressed by this Commission. The generating facility in question was constructed and operated as a qualifying cogeneration facility pursuant to PURPA. The Commission did not issue certificates for these facilities at the time they were constructed based on its interpretation of PURPA. The facility now wishes to operate solely as an electric generating facility in the Commonwealth and not as a PURPA-qualified entity, selling power at wholesale to one customer, Virginia Power. Many of the issues brought forth by the Petition involve the scope of the Commission's authority under relevant provisions of the Facilities Act and the Act, particularly, Code §§ 56-265.2, 56-265.3 and 56-580 D, as well as FERC's authority under various provisions of PURPA and other relevant statutes.

NOW, in consideration of the foregoing, the Commission is of the opinion and finds that this matter should be docketed and interested persons be given notice and provided an opportunity to file comments on Birchwood's Petition.

Significantly, Birchwood is representative of a number of QF facilities in this Commonwealth that were constructed as QFs under the aegis of PURPA and operated as such under PURPA's cogeneration constraints. However, these QF facilities were not required to obtain certificates of public convenience and necessity under Virginia's Facilities Act as a prerequisite to their construction and operation. Consequently, Birchwood's application puts this Commission in the unusual posture of passing on the Facilities Act's certification requirements with respect to a plant that is already sited, constructed, and operational.

Birchwood's legal arguments set forth in its Petition amply demonstrate that neither the Facilities Act nor the Act's "merchant plant" statute (§ 56-580) provide an explicit answer

to the overarching legal issue this application presents: What certification or approval, if any, is required from the Commission in conjunction with the transformation of an operational QF facility within the Commonwealth into non-QF facility? Because the outcome of this issue is significant not only to the Company and others like it but also to Virginia's wholesale market in connection with the movement to retail competition, we believe that stakeholders and other parties interested in this issue should be provided an opportunity to comment thereon.

Accordingly, IT IS ORDERED THAT:

(1) This matter is docketed as Case No. PUE010719 and all associated papers shall be filed therein.

(2) On or before March 27, 2002, the Commission Staff and any interested persons may file an original and fifteen (15) copies of written comments on the Petition with Joel H. Peck, Clerk, State Corporation Commission, c/o Document Control Center, P.O. Box 2118, Richmond, Virginia 23218. Comments shall refer to Case No. PUE010719. ORDER GRANTING MOTION FOR EXTENSION

On February 7, 2002, the Staff of the State Corporation Commission ("Staff"), by counsel, filed with the State Corporation Commission ("Commission") a Staff Motion for Extension to File Proposed Rules and Report ("Motion"). The Motion requests that the Commission extend the time for the Staff to file proposed rules for consolidated billing services, and the Staff report in support of such proposed rules, from February 14, 2002, and February 28, 2002, respectively, to May 24, 2002 (for both the proposed rules and Staff report). The Motion also requests a corresponding extension in the time for interested parties to file comments and requests for hearing on the proposed rules and Staff report from March 22, 2002, to June 27, 2002.

Section 56-581.1 of the Virginia Electric Utility Restructuring Act (the "Act") requires the Commission to promulgate rules and regulations for competitive billing services, including consolidated billing.

In support of the Motion, the Staff described in some detail the efforts of the work group formed to assist the Staff in developing proposed rules. The Motion explained that at an October 2, 2001, work group meeting, several participants volunteered to participate in a subgroup to identify competitive service provider ("CSP") consolidated billing issues and develop a "strawman" rules document. The subgroup developed an extensive issues list, but was unable to develop a strawman. The Staff advised that the full work group met eight days during December, January, and February to discuss and evaluate the issues identified by the subgroup, and has two additional meetings scheduled for late February.

The Motion states that during the course of the work group meetings, the Staff developed a fuller appreciation of the complexity of issues associated with CSP consolidated billing. The Staff explains that when the CSP performs consolidated billing, one party, the CSP, controls the issuance of the bill and the processing of customer payments while another party, the LDC, controls service disconnection activities for non-payment of its regulated charges. This separation of responsibilities may result in increased opportunities for confusion that, in turn, could be potentially detrimental to the advancement of competition in the Commonwealth.

The Staff contends that due to the complexity of issues associated with CSP consolidated billing, and based on its opinion that additional analysis and input from the work group are necessary to develop proposed rules that will reasonably ensure billing accuracy and timeliness, as well as minimize the potential for confusion and unwarranted credit action against consumers, the Staff requires additional time to develop proposed rules for CSP consolidated billing.

The Staff believes it is essential that the work group identify and perform a more comprehensive and detailed review than originally anticipated of possible billing scenarios with respect to assumptions regarding customer switching, payment remittance, arrearages, payment arrangements, pending disconnection, budget billing, multi-period billing adjustments, bill cancellation and rebilling (catastrophic and minor data processing, billing and metering errors), and other key variables. According to the Staff, this detailed level of review

may require significant interaction with and assistance from the Virginia Electronic Data Transfer Working Group that oversees the development of standardized business practices and electronic data communication protocols.

The Staff notes in its Motion that several incumbent electric utilities have advised the work group that approximately nine months will be required for the development and testing of electronic data exchange protocols and LDC billing system modifications subsequent to the Commission's adoption of final rules. The Motion advises that the Commission should reasonably anticipate that parties to this proceeding will request a delay, as provided for in § 56-581.1 C, beyond the January 1, 2003, target date for CSP consolidated billing.

In further support of the Motion, the Staff states that, at present, only one supplier in Virginia, The New Power Company, has expressed significant interest in CSP consolidated billing; and that The New Power Company has informed Staff that it does not object to this requested extension. The Staff further states that, on February 5, 2002, it informed all persons having filed a statement of interest in this proceeding of the Motion, and was advised by the following interested parties that they do not object to the requested extension: AES New Energy; Allegheny Energy Supply Company; Appalachian Power Company d/b/a American Electric Power - Virginia; Delmarva Power & Light Company; Itron; Virginia Electric and Power Company; Division of Consumer Counsel, Office of Attorney General; The Potomac Edison Company d/b/a Allegheny Power; and the Virginia, Maryland & Delaware Association of Electric Cooperatives. No interested party has opposed the Motion.

NOW THE COMMISSION, having considered the Motion, the absence of opposition from interested parties, and the applicable law, is of the opinion that the request is reasonable and should be granted.

Accordingly, IT IS ORDERED THAT:

- (1) The February 7, 2002, Staff Motion for Extension to File Proposed Rules and Report is granted.
- (2) The time for the Staff to file proposed rules for consolidated billing services is extended from February 14, 2002, to May 24, 2002.
- (3) The time for the Staff to file a report on its proposed rules for consolidated billing services is extended from February 28, 2002, to May 24, 2002.
- (4) The time for interested parties to file comments and requests for hearing on the proposed rules and Staff report is extended from March 22, 2002, to June 27, 2002.
- (5) The Staff and interested parties shall, except as otherwise provided above, make their filings in accordance with ordering paragraphs (7) and (8) of the Commission's May 15, 2001, Order Establishing Proceedings in this case.
